1. The Volta River Authority (VRA) of the Republic of Ghana intends to apply part of its budgetary allocation to fund eligible payments under the Contract for **Rehabilitation of Civil Works at Navrongo Solar Power plant in the Upper East Region of Ghana.**

The Works comprises the rehabilitation of sections of the control building, 3no. inverter buildings, guard house and surfacing the plant yard with granite chippings.

2. The Volta River Authority invites sealed tenders from eligible Contractors who have registered with the Ministry of Works and Housing and with a minimum financial classification certificate of D2 / K2.

The total estimated period for the completion of the project is **Six (6) Months.**

3. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Act, 2003 (Act 663) and the Public Procurement (Amendment) Act, 2016 (Act 914) and is open to all tenderers as defined in the Guidelines of the Public Procurement Authority of the Republic of Ghana.

6. Tenders shall be completed, sealed and marked **“REHABILITATION OF CIVIL WORKS AT NAVRONGO SOLAR POWER PLANT”**, addressed to the Chief Executive, Volta River Authority, P. O. Box MB 77, Accra, Ghana and **delivered to the Engineering Services Department Conference Room, VRA – Akuse, in the Eastern Region** on **March 29, 2018** by 11:00hours GMT. Tenders shall be valid up to **180 days** after the deadline of Tender submission. All tenders must be accompanied by a tender security of **Ten Thousand Ghana Cedis (GHS10,000.00)**. The tender security shall remain valid for **28 days** after the validity of Tenders.
7. Tenderers who wish to visit the project site, at their own cost, shall meet at the Navrongo Solar Power Station in the Upper East Region at **11:00am** on **March 16, 2018.**
