Contract Title: Rust Control Service for VRA Thermal Power Plants

1. The **Volta River Authority** (the “Employer”), intends to apply a portion of its Budgetary Allocation to cover eligible payments under a contract for which this Invitation for Tenders (“IFT”) is issued.
2. The scope of the Works expected to be awarded under this IFT includes but not limited to the controlling rusts (involving inspecting, refurbishing, rehabilitating, repairing, replacing (where necessary) on VRA’s Thermal plants/equipment at Aboadze and Tema.

The project is expected to be completed in **eighteen (18) calendar months**.

The Volta River Authority now invites sealed Tenders from eligible service providers of Rust Control Services for VRA Thermal Power Plants

3. More details on the requirements are provided in the Specifications and Bills of Quantities included in the Tender Documents accompanying this IFT
4. This IFT is open to all eligible and qualified Tenderers who have registered with the Public Procurement Authority and can demonstrate of having provided similar services.
5. A Contractor will be selected under a competitive Tendering method through the evaluation procedure which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 (Act 663) as amended which are provided on the PPA website at www.ppa.gov.gh

A complete set of Tender Documents in English may be purchased from the office of the address stated above, from **09:00 to 15:00 hours GMT** each working day from **June 17, 2019 to July 19, 2019** by interested Tenderers upon payment of a non-refundable fee of GHS 300.00 for each set of Tender Documents. The method of payment will be by Banker’s Draft or cash payable to Volta River Authority.
8. **A mandatory site visit and pre-tender meeting shall be held for all Tenderers.** Eligible Tenderers are therefore required to meet at the office of the Director, VRA Thermal Generation Department located within the Administration of Takoradi Thermal Power Station at Aboadze in the Western Region at 11:00am on **July 03, 2019**. **The Tender of any Tenderer who fails to attend the mandatory site visit and pre-tender meeting shall be rejected.**
9. Tenders shall be valid up to 180 days after the deadline of Tender submission. All tenders must be accompanied by a tender security of **Three Hundred and Fifty Thousand Ghana Cedis (GHS350,000.00)**. The tender security shall remain valid for **28 days after the validity of Tenders** (i.e. 208 days after deadline of Tender Submission).
10. All Tenders in one original plus two (2) copies, properly filled in, and enclosed in plain envelopes

must be delivered to **Engineering Services Department Conference Room, VRA – Akuse, in the Eastern Region at or before 13:00 hours GMT on July 19, 2019.**

11. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend the opening at the Engineering Services Department Conference Room, VRA – Akuse, in the Eastern Region.
