NATIONAL COMPETITIVE TENDERING

Contract Title: Spillway Power Supply Rehabilitation (Two Sets of 3.3/0.415kV Packaged Outdoor Transformers, 4km of 3 x 16 sq.mm 3-5kV Cables, Reinforced Steel Conduits)

1. The **Volta River Authority** (the "Employer"), intends to apply a portion of its Budgetary Allocation to cover eligible payments under a contract for which this Invitation for Tenders ("IFT") is issued. The IFT reference number is **GR/VRA/WK/0012/2018**
2. The scope of the Works expected to be awarded under this IFT includes but not limited to the procurement and installation of two new packaged 3.3/0.415kV, 250kVA transformers at Akosombo Generating Station in the Eastern Region of Ghana for power supply to the spillway gates.

The project is expected to be completed within **eight (8) calendar months**.

The Volta River Authority now invites sealed Tenders from eligible contractors for the Design, Manufacture, Testing, Delivery to site and erection of the transformers, Associated panels, Reinforced steel conduit and Cabling.

3. More details on the requirements are provided in the Specifications and Activity of Schedules included in the Tender Documents.
4. This IFT is open to all eligible and qualified Tenderers who have registered with the Public Procurement Authority and can demonstrate experience of having provided similar services.
5. A Contractor will be selected under a competitive Tendering method through the evaluation procedure which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 (Act 663) as amended.
6. Eligible Tenderers interested in obtaining Tender Documents may obtain further information from and inspect the Tendering Documents at the following address from **09:00 to 15:00 hours GMT** on Mondays to Fridays (inclusive) except on public holidays from **July 22, 2019 to August 28, 2019**.

A complete set of Tender Documents in English may be purchased from the office of the address stated above, from **09:00 to 15:00 hours GMT** each working day from **Monday, July 22, 2019 to Wednesday, August 28, 2019** by interested Tenderers upon payment of a non-refundable fee of **GHS 300.00** for each set of Tender Documents. The method of payment will be by Banker's Draft or cash payable to Volta River Authority.

8. **A Mandatory Site visit and Pre-tender meeting shall be held for all Tenderers.** Eligible Tenderers are therefore required to meet at Akosombo Generating Station Conference Room, near the Akosombo Generating Station, Akosombo in the Eastern Region at **10:30 a.m. on August 07, 2019. The Tender of any Tenderer who fails to attend the Mandatory Site visit and Pre-tender meeting shall be rejected.**
9. Tenders shall be valid up to 180 days after the deadline of Tender submission. All tenders must be accompanied by a tender security of **Twenty Thousand Ghana Cedis (GH¢20,000.00). The Tender Security shall remain valid for 28 days after the validity of Tenders** (i.e. 208 days after deadline of Tender Submission).
10. All Tenders in One original plus Two (2) copies, properly filled in, and enclosed in plain envelopes must be delivered to **Engineering Services Department Conference Room, VRA – Akuse (EL-1014-5842) in the Eastern Region at or before 12:00 hours GMT on Wednesday, August 28, 2019.**
11. Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend the opening at the Engineering Services Department Conference Room, VRA – Akuse, in the Eastern Region.
