Contract Title: Dry-Docking and Repair Works of Aboadze Single Point Mooring (SPM)

- 1. The Government of the Republic of Ghana, acting through the Volta River Authority (the "Employer"), intends to apply a portion of its Internally Generated Funds for eligible payments under a contract for which this Invitation for Tenders ("IFT") is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the funding and conditions to the disbursement of funding. No party other than the Government and the Employer shall derive any rights from the funding or have any claim to the proceeds of the funding.
- 2. The Works and the Contract expected to be awarded under this IFT is **Dry-Docking and Repair Works of Aboadze Single Point Mooring (SPM)** to be completed in **six (6) calendar months.**

The scope of the Works expected to be awarded under this IFT includes but not limited to the detailed survey, uninstallation, dry-docking, repair, reinstallation and testing of the SPM, and the replacement of a 24" spool piece at Aboadze in the Western Region of Ghana

- 3. The **Volta River Authority** now invites sealed Tenders ("Tenders") from eligible and qualified entities or persons ("Tenderers") to provide the works referenced above.
- 4. More details on the requirements are provided in the Bill of Quantities, Specifications and Drawings included in the Tender Documents accompanying this IFT.
- 5. This IFT is open to all eligible and qualified Tenderers who wish to respond to the "Tender Documents and can demonstrate experience of having executed similar projects. Qualification requirements are as described in **Section III. Evaluation and Qualification Criteria.**
- 6. A Contractor will be selected under a competitive Tendering method through the evaluation procedure, which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 (Act 663) as amended which are provided on the PPA website at www.ppa.gov.gh.

The method of payment will be by Banker's Draft or Cash payable to Volta River Authority.

- 9. A mandatory Site Visit and Pre-Tender meeting shall be held for all Tenderers. Eligible Tenderers are therefore required to meet at the Conference Room of Takoradi Thermal Power Station, Aboadze in the Western Region of Ghana at 11:00am on August 01, 2019. The Tender of any Tenderer who fails to attend the Mandatory Site Visit and Pre-tender meeting shall be rejected.
- 10. The deadline for submission of Tenders is **August 16, 2019** at **13:00Hrs GMT**. Tenders must be delivered to **the Engineering Services Department Conference Room, VRA Akuse, in the Eastern Region** at or before the time specified above.
- 11. Tenders shall be valid up to **180 days** after the deadline of Tender submission. All tenders must be accompanied by a tender security of **One Hundred and Twenty-Five Thousand Dollars (US\$125, 000.00)**. The tender security shall remain valid for **28 days** after the <u>validity of Tenders</u> (208 days after deadline of Tender Submission)
- 12. Tenders will be opened immediately after 13:00hours GMT on **August 16, 2019** in the presence of Tenderers' representatives who choose to attend at the Engineering Services Department Conference Room, VRA Akuse in the Eastern Region.
