  - Supply and installation for new Doors and Glazed windows and associated Ironmongery
  - Supply and installation of Spilt Type Air Conditioners
  - Supply and Installation of Tiling and repainting of Building
  - Associated Electrical Installation works
  - Associated Plumbing Pipe and Installation works

The project is expected to be completed within Six (6) Calendar months.

- 5. A Contractor will be selected under National Competitive Tendering(**NCT**) method through the evaluation procedure which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 (Act 663) as amended which are provided on the PPA website at www.ppa.gov.gh.
