ENTERPRISE VOICE OVER INTERNET PROTOCOL (VoIP) TELEPHONY SYSTEM PROJECT

The Volta River Authority (VRA) intends to apply part of its Budgetary Allocation to make payments under the contract to deploy and maintain Avaya Enterprise Voice over Internet Protocol (VoIP) systems.

The scope of the project includes but not limited to:

- Two Server-based (primary and secondary) Public Branch Exchanges (PABX) to be deployed one each at the datacenter (DC) and disaster recovery (DR) site for redundant supply of VoIP services including a Billing Software;
- ii. About Six Hundred (600) IP Telephony endpoints to replace existing Analog legacy Telephone Handsets in all work locations (Accra, Tema, Akuse, Akosombo, Ada, Navrongo and Aboadze) of the Authority.
- iii. Provide preventive and corrective maintenance services after deployment for one year (renewable);
- Migrate existing IP Telephony endpoints currently on locational PABXs in all work locations where they exist (Accra, Tema, Kpone, Akuse, Akosombo and Navrongo) to the central PAB
- v. Existing locational IP PABX boxes serving various locations to be repurposed to provide location/branch survivability in case of WAN outage to the location/branch;
- vi. ISDN resources from Vodafone to be redistributed to serve business requirements especially at the various power houses of our generation plants (Akosombo, Akuse, Aboadze, Kpone and Tema), Head Office and other required areas/offices as may be identified.

A. The VRA now invites eligible service providers, companies or organisations registered in Ghana to indicate their interest in providing the service.

B. Interested Firms must provide Expression of Interest (EOI) for the service with the following mandatory requirements and other additional information listed below:

 - Registration with the Public Procurement Authority as a Service Provider.
