The Volta River Authority (VRA) intends to apply part of its Budgetary Allocation to payments under the contract for the preparation of Oil Spill Contingency Planning Reports for the Volta Lake System.

The services required include updating of the existing “Oil Spill Contingency Plan for the Volta Lake Transport Company” to synchronize with the National Oil Spill Contingency Plan and preparation of an “Oil Spill Contingency Planning Framework Document for the Volta Lake System”.

The Consultancy Services are expected to commence in October 2020 for a period of Four (4) man-months.

The VRA now invites eligible **GHANAIAN** Consulting Firms to indicate their interest in providing the services. Interested individual consultants must provide information indicating that they are qualified to perform the services (Brochures, Description of similar assignments including project costs, Experience in similar conditions, Availability of appropriate skills among staff, etc.). Consultants may associate to enhance their qualifications.

The EOI is open to all eligible and qualified Consultants who have registered with the Public Procurement Authority (PPA).

A consultant will be selected in accordance with the procedures set out in the Public Procurement Act, 2003 (Act 663) as amended by the Procurement Amendment Act, 2016 (Act 914), of the Republic of Ghana.

Only shortlisted firms will be invited for the Second Stage of the procurement process (Request for Proposal) leading to a final selection of the successful firm.
