- 8. A **Mandatory** Site Visit and a Pre-Tender meeting shall be held for all Tenderers. Eligible Tenderers are therefore required to meet at the VRA Central Warehouse near Tema Steel Works at Tema in the Greater Accra Region at **11:00 hours** GMT on **Tuesday**, **May 24, 2022**.

The Tender of any Tenderer who fails to attend the mandatory site visit and pre-tender meeting shall be rejected.

- 10. Tenders shall be valid up to **180 days** after the deadline of Tender submission. All Tenders must be accompanied by a Tender Security of **Ten Thousand Ghana Cedis (GHS10, 000.00)**.
