  - Reconstruction of concrete chemical dosing tanks, construction of cable trenches and the supply and installation of metering pumps and electrical motor mixers complete with all necessary cables and fittings accessories.

The project is expected to be completed in Twelve (12) calendar months.

The **Volta River Authority** now invites sealed Tenders ("Tenders") from eligible and qualified entities or persons ("Tenderers") to provide the works referenced above.

- 4. This IFT is open to all eligible and qualified Tenderers who have registered with the Public Procurement Authority, Ministry of Works and Housing and with a minimum financial classification certificate of D1/K1 OR G1 and can demonstrate experience of having executed similar projects.
- 5. A Contractor will be selected under a competitive Tendering method through the evaluation procedure which is described in the Tender Documents, in accordance with the Public Procurement Act, 2003 (Act 663) as amended which are provided on the PPA website at www.ppa.gov.gh.

Eligible Tenderers are therefore required to meet at VRA's Real Estate Office in Akosombo in the Eastern Region at 11:00am on October 11 2018. The tender of any tenderer who fails to attend the mandatory site visit and pre-tender meeting shall be rejected
- 9. The deadline for submission of Tenders is October 26, 2018 at 13:00Hrs GMT. Tenders must be delivered to the Engineering Services Department Conference Room, VRA Akuse, in the Eastern Region at or before the time specified above.
- 10. Tenders shall be valid up to 180 days after the deadline of Tender submission. All tenders must be accompanied by a tender security of One Hundred and Forty Thousand Ghana Cedis (GHS140,000.00).
