## PROVISION OF DRONE TECHNOLOGY SERVICES

### REQUEST FOR EXPRESSION OF INTEREST (EOI)

The Volta River Authority (VRA) intends to apply part of its Budgetary Allocation to payments under the contract for the provision of Drone Technology Services for Surveying, Mapping, Engineering, Construction and Environmental protection activities, mainly along the Volta Lake. The VRA now invites Eligible and Reputable Drone Technology Service Providers, Companies or firms to indicate their interest in providing the said services for a **Three (3)-year period**.

The VRA now invites eligible **GHANAIAN** Firms to indicate their interest in providing the services. Interested Consulting Firms must provide information indicating that they are qualified to perform the services (Brochures, description of similar assignments including project costs, experience in similar conditions, availability of appropriate skills among staff, available resources such as vehicles, IT equipment as well as scientific analytical equipment for use on the assignment etc.). Firms may associate to enhance their qualifications. Interested Firms should note that they may be required to make presentations on their proposed services as part of the EOI process.

Lead Firms are expected to prove their legal existence, provide Audited Reports by Certified Auditors for years 2015 – 2017 as well as evidence of fulfilling their tax obligations during the same period. A firm will be selected in accordance with the procedures set out in the Public Procurement Act, 2003 (Act 663) as amended by the Procurement Amendment Act, 2016 (Act 914), of the Republic of Ghana.
