It is my firm belief that the New Year will bring us renewed hope, good health, long life, energy and greater success.

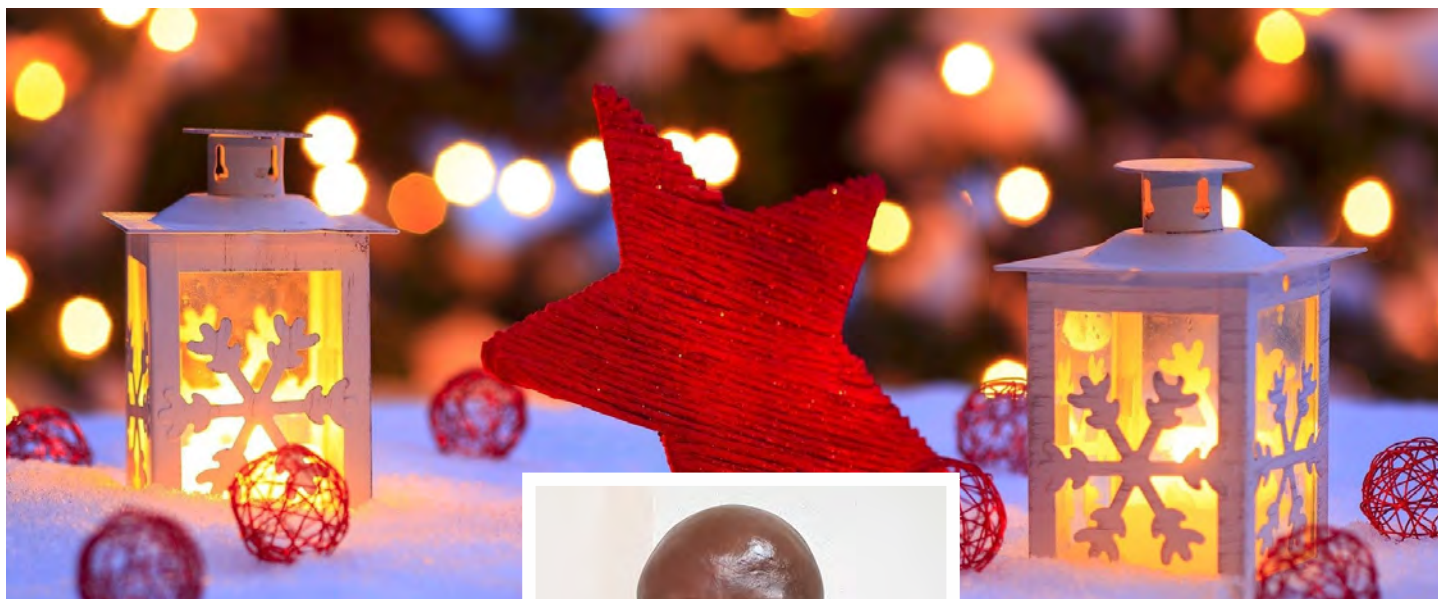

The year saw the Authority continuing with the implementation of its Flagship 5-year strategic plan dubbed 'BRAISE' aimed at restoring the finances of the Authority.

We started the year very hopeful of executing myriad of projects planned for the year. However, with the advent of the COVID-19 pandemic and its attendant effects on lives, sub-regional and world economies, some of our activities experienced some delays. As a department, we have had to restructure and re-prioritize our activities as part of a concerted effort by the Authority towards the push to attaining Financial Recovery and also meet our own set targets.

I am proud to have such dedicated staff in the Engineering Services Department who are willing to work under harsh and unfavourable conditions just to accomplish set targets. It is gratifying to note that notwithstanding the challenges faced by the Authority as a result of the pandemic and for which reason we have had to forgo certain privileges at

times, the department I must say stayed on course and still achieved some successes in its assigned responsibilities, notable among them being the completion and commissioning of the 6.5MW Solar Power Project in Lawra, and the Solar Plant at Kaleo which is on schedule and expected to be commissioned early 2021, completion of Supply and Installation of Unit Transformer for TTPC Station 2, awarded contract for commencement of Akuse rooftop solar project for institutional and residential buildings, completion of Geotechnical Investigation for site for remodeling of VRA Academy Phase 3, issued RFP for Transaction Advisor for 75MW Wind Power Project 1 Studies and conducted Appraisal Mission with KfW on the Kaleo Solar Power Project 2.

For other infrastructural projects, the rehabilitation works on the Oxidation Pond for Akosombo was completed

and taken over and that of Akuse expected to be completed by the end of the year. Rehabilitation and conversion of the Administration Building into VRA Hospital Annex in Aboadze was completed, completed Construction of Storm Drains along Casely Hayford High Street in Akosombo and completed Rust Control Refurbishment Works for Aboadze and Tema Thermal Plants. As Owner's Engineers for the Ministry of Energy, a number of SHEP IV projects were substantially completed in the Northern, Bono East, Ahafo and Bono Regions of the country.

The department also fulfilled its mandate of collecting hydro-meteorological data from the Volta Catchment area as input for flood forecasting and lake monitoring which will guide the Authority in its operations, especially the sustainable drafting of the lake for hydropower generation. This culminated in the prediction of good inflow into the Volta Lake and a projected reservoir elevation of 269.04 at the end of the flood season, and from all indications we are likely to stay within the projected elevation a feat which deserves commendation. We also developed the Energy Capacity Supply Balance for 2021 and carried out the mandated Quarterly Updates to the 2020 Energy Supply Plan to guide

decision making by the Executive and also guide the operation of the Authority's plants. Dam Safety Monitoring proceeded as planned with safety checks being conducted after the earthquake in Accra in June 2020.

The year under review unfortunately saw the passing on of one of our own, Nicholas Yao Dzodogbe (Principal Driver). May his soul rest in perfect peace till we meet.

In the coming year, the need for prudent management of resources and the need to avoid profligate expenditure as far as the department's budgetary allocation is concerned cannot be overemphasized since the Authority's finances are not out of the woods yet. I hope I can once again count on your support when called upon to make some sacrifices.

I am of the conviction that staff of the department would in the coming year and years ahead continue to live the tenets of the 'BRAISE'/New VRA even as the Authority strives to sustain and consolidate the gains under the first phase of the Financial Recovery Plan and help the Authority become a resilient, sustainable and growing organization capable of withstanding any competition within the Energy Sector.

It is my expectation that in spite of the fact that COVID-19 is still raging on, together we will strategize to contain the effects of the pandemic on our activities and forge ahead to achieve greater success in the coming year and the years ahead even as we continue the expansion of Kaleo and Lawra Solar Projects from 17MW to 35MW and also the development activities of the wind power projects. It is therefore my hope that each and every one of us will put his/her shoulders to the wheel so that together we can address the challenges ahead to enable the Authority, in general, and the Engineering Services Department, in particular, meet their set targets. My fervent prayer is that you will all exhibit the same conscientiousness, team spirit and dedication to duty to enable the department pursue its mandate.

May I on behalf of Management and myself take this opportunity to express my gratitude towards you all for your hard work and dedication to duty and wish you and your families Merry Christmas and a Happy and Prosperous New Year.
